Acres in Preserve (Owned): Also referred to as "acres purchased in fee." Acres purchased and owned outright by the conservancy as nature preserves or sanctuaries often accessible by the public

Acres under Easement: Total acres a conservancy protected by conservation easement. These do not include acres that are under management agreement.

Transfer and Assists: Total acres a conservancy has transferred and/or total acres a conservancy significantly assisted another entity (e.g. local government, State of Michigan) in securing as park land/open space or placing a conservation easement on a property.

Acres under Management Agreement: Total acres a conservancy manages/stewards a property but another entity owns it.
